ROARING BROOK TOWNSHIP BOARD OF SUPERVISORS

The regular meeting of the Roaring Brook Township Board of Supervisors was held on Thursday, February 5, 2015 at 8:00 P.M. at the Municipal Building on Blue Shutters Road. Present were Supervisors Tony Jordan and Eric Schield, Chief Don Hickey, Gerard Hetman from Lackawanna County, Debbie Bertha, Marc Gaughan, Tom and Will Enkulenko, Jamie Pabst, Michelle Koelsch and Atty Michael O'Brien. Supervisor Bob Farischon was absent.

An executive session was held prior to meeting to discuss potential litigation.

PUBLIC COMMENT

- Gerard Hetman from the County: Copy of County map with all streets in Lackawanna County, notice for the 2015
 Municipal Arts & Culture Grant for \$500, Penn State Extension Program Information on Diabetes and Strength Training
 Classes.
- Debbie Bertha from North Pocono Trails Association there is a license agreement with PA American Water Co. for a maintenance agreement for the 6/10 of a mile trail section in Roaring Brook Township. Total for trail that goes from the Moscow Sewer Authority to Roaring Brook Township by the reservoir is 10 miles.

Schield said there has been an agreement between Cal Ripken and Dandy Lion regarding the Porta Potty and gazebo. We should get a use agreement for use of the pavilion, i.e. trash removal.
- Jordan said if the Recreation Commission designated a recreation project which would require additional funds the Board
 of Supervisors would consider their request on a project by project basis.
