  several weekends. New owner lives in Connecticut. R-l area does not list transient use.
- Attorney O'Brien said the police should be called when it's is too loud or you hear gunshots. Land use issue Commonwealth Court heard a case from Monroe County that is similar to this house. Commonwealth Court said if there is nothing in Township Ordinance it is allowable. Homeowner is using property as a residence not as a commercial use.
- There is concern about fire regulations in home.
- Township Rental Ordinance requires homeowner to register with Township names of renters.
- If property is rented room by room then there may be a strong case the Township could stop that use.
- Jeffrey Pellis asked if there is any update for speed limit for Golf Club Road. Jordan said Ordinance is on agenda for setting speed limit for Gold Club Road, Windsor Hill and Summit Woods Developments.
- Diane Walls requested speed limit in her neighbor.. Schield said it meets the residential standard for 25 mph and no speed study is needed. The speed limit in a development is 25 mph.
- Schield said Township is looking into getting 2 speed trailers that register the speed limit and flash the mph.
- Chris Caputo is running for Magistrate's office. He stated he was in DA's office and is the only candidate with criminal trial experience.
- Paul Kozik said report of well testings is good.
