The regular meeting of the Roaring Brook Township Board of Supervisors was held on Thursday, June 7, 2018 at 8:15 pm at the Municipal Building on Blue Shutters Road. Chairman Jordan announced prior to the meeting a hearing was held for proposed changes to the Zoning Map and Zoning Ordinance and Subdivision Ordinance. He also reported an executive session with the attorney to discuss possible litigation.

#### **ACTION ON CORRESPONDENCE**

- Jordan said the Overlook Lane lot sale for the price of \$1.00 would not be fair. If the Supervisors decide to sell the lot as surplus property they would have to follow the 2<sup>nd</sup> Class Township Code and put it out for bid, probably establishing a minimum bid.. Township accepted the lot when a property owner had two lots one with an EDU connection and another without. The EDU connection was transferred to a different property and the owner give the lot on Overlook to the Township.
- Jordan reported a renewal contract was signed with Comcast in 2017 and the Township's franchise fee was increased.
- A MOTION by Farischon was seconded by Schield to accept with regret the resignation of Officer Patrick Chelland. Motion carried.
- Jordan commented there have been numerous calls about the fallen tree on the Verizon line by the ponds on Blue Shutters Road. The Township has made several attempts to notify Verizon. Jordan and Schield met with representatives from PennDot and inquired if the line is in PennDot's right of way.

   Chief Hickey said the police were patrolling the area more frequently and they tried contacting the water company via the Communication Center with no response from the water company.

Jordan said the Supervisors are reviewing a maintenance Ordinance that would include noise. Also, there is going to be a meeting between our Roadmaster, our engineers and the PA American Water Company about the poor paving job done last year by the work company and ATVs on the water company will be mentioned.
