ROARING BROOK TOWNSHIP BOARD OF SUPERVISORS

The regular meeting of the Roaring Brook Township Board of Supervisors was held on Thursday, July 7, 2016 at 8:00 P.M. at the Municipal Building on Blue Shutters Road. Present were Supervisors Tony Jordan, and Eric Schield, Atty Joseph O'Brien, Chief Don Hickey, Gerard Hetman, Patricia Pallien, Linda & Art Christianson, Marianne Cummings, Monica & Joe Scaduto, Lil Dippre, Sally Douaihy, Diane & Bud Walls. Supervisor Farischon was absent from meeting.

PUBLIC COMMENT

Gerard Hetman announced the following events and information from the Lackawanna County Commissioners:

- Locations where unused or expired medications can be dropped off are Lackawanna County Courthouse, Moscow Borough Police Department, City of Carbondale Police Department and South Abington Township Police Department.
- The beach at Covington Park is open. Swimming hours are Monday through Sunday from 11 AM -7 PM. Lifeguards will be there through mid-August.

- Dates for Art in the Park -10 a.m. -12 noon with free art activities for kids.

We were told only a portion of the requested would be funded. We are waiting for approval. Hetman said he would see about the status of the application.
