# THURSDAY, August 6, 2015 REGULAR MONTHLY MEETING ROARING BROOK TOWNSHIP BOARD OF SUPERVISORS

The regular meeting of the Roaring Brook Township Board of Supervisors was held on Thursday, August 6, 2015 at 8:00P.M.at the Municipal Building on Blue Shutters Road. Present were Supervisors Tony Jordan, Robert Farischon and Eric Schield, Chief Don Hickey, Gerard Hetman from Lackawanna County, Solicitor Joseph O'Brien, Paul Kozik, Ann Marie Scott, Eric Jordan, Lou Ferrari, Tom Ferrari, Al Magnotta, Ed Marushock, Sally Smith, Robert Smith, JR Smith, and Jim Lockwood from The Times.

An executive session was held prior to the meeting for potential litigation.

#### **PUBLIC COMMENT**

- Albert Magnotta addressed the Supervisors as a representative of WBD, Inc., the owner of property adjacent to Route 307. The property is located in an S-1 zone. Mr. Magnotta indicated that the property had been previously owned by the Pennsylvania American Water Company and that the PUC had allowed the sale of the property, even though it was in the water shed area, because there was a 500' buffer from the high water mark. Mr. Magnotta indicated that his clients would be seeking a zone change on the property. Mr. Magnotta indicated that there was a facility on the premises that was maintaining and servicing motor vehicles related to the permitted uses on the premises and other motor vehicles of related enterprises. He asked for a temporary permit to continue this work until such time as the zoning change would occur. Otherwise, the company would be required to shut down the facility and lay off 15 workers. Mr. Magnotta also reported that complaints about the facility had been completely cleaned up after recent stories in *The Scranton Times*, that DEP had been at the site, and that there were no violations at the facility.

James Lockwood, a reporter for the *Times*, had questions of the Supervisors, the Solicitor, and Mr. Magnotta. Mr. Lockwood questioned why no citations had been issued as a result of the violations at the facility. The Solicitor explained that, under the Township Zoning Ordinance, an individual who has been notified of a zoning violation has the opportunity to cure before a notice of violation or a citation is issued. In this case, the facility had been inspected by the Township Zoning Officer and the property had been cleaned up and, other than the matter at hand involving the repair to the facility, all zoning violations had been resolved.

Mr. Lockwood also raised questions about the ownership of the bridge. The Solicitor informed Mr. Lockwood that there was a question or dispute about the ownership of the bridge. The Township is taking the position that it owned the bridge and WBD, Inc. taking the position that it owned the bridge. The Solicitor agreed to look into the matter.

Mr. Lockwood also requested that the decision on the request for a temporary zoning permit be made at a public meeting. The Supervisors agreed and announced that they would announce their decision at their work session scheduled for August 17, 2015.
