PUBLIC COMMENT

- Atty Michael O'Brien re: DEP and Ross property. Lawyers for DEP and lawyers for Ross are working out a consent agreement to alleviate the problem. Nothing is settled yet but O'Brien said they would take corrective action. The agreement will have both Ross and DEP sign contract isn't executed yet, not a complete contract. O'Brien said discussion is still ongoing. Ross and DEP will both have to sign agreement.
- Jordan said DEP and Ross are not ignoring problem and are taking care of it now.
- Supervisors will sign and send correspondence to Edward Jones Investors to authorize Edward Jones and to utilize them for Township investments.
