# THURSDAY, August 3, 2017 REGULAR MONTHLY MEETING ROARING BROOK TOWNSHIP BOARD OF SUPERVISORS

The regular meeting of the Roaring Brook Township Board of Supervisors was held on Thursday, August 3, 2017 at 8:00 pm at the Municipal Building on Blue Shutters Road. Present were Supervisors Anthony Jordan, Robert Farischon and Eric Schield, Attorney Michael O'Brien, Chief Donald Hickey, Paul Kozik, Gerard Hetman for the County, Danielle Chick, John & Pat Pallien, Joe & Monica Scaduto, Paul & Pat Rinaldi and Matthew Zeller.

#### **PUBLIC COMMENT**

- Gerard Hetman Air Show August 12 & 13, Fall Events; Triple AAA Baseball Championship Game September 19, Heroes Day - September 16, Senior Health Day - September 23, Annual Recycling Meeting – August 23 @ 911 Center, County Annual Tire Recycling – September 13 - September 16.
- Pat Pallien spoke about speeders on Wilson & Wilcrest and asked if a stop sign or a speed bump can be installed. Jordan said stop signs are to control flow of traffic not to slow people down. Schield said speed bumps are illegal on roads. Chief Hickey will act on the complaint.
- Pat Rinaldi RE: letter sent last month about drains on Yedinak Lane was to be sent to PennDot. Property owners knew Township did not install drains. They apologized that their lawyer sent the letter to the Township without their knowledge. They have not received a response from PennDot. Jordan said he will contact Mike Carroll to see if he can get an answer from PennDot.
- Matt Zeller from Homestead Drive regarding storm drain grate said PennDot says a bicycle should be able to ride over the grate. Jordan said that kind of grate was put in because the driveways were being washed away. Grate was installed to take care of excessive runoff. Schield said he talked to Mr. Zeller and grate was put in 10 years ago. Schield said it was installed to handle the runoff and is PennDot approved because it is not in cartway. Other drains are only 6" and Township needs to get a company in to clean outpipes. This will be done to more than one drain. Township will eventually have to address issues in the future. Jordan asked what does Mr. Zeller want Township to do. Zeller said he would like grate changed so a bike can ride over it.
