Planned communities - Acts 37 and 38 of 2015– amend the Uniform Planned Community Act and the Uniform Planned Condominium Act clarifying that creating a planned community or condominium out of existing land for estate purposes does not constitute a subdivision or land development as defined in the Municipalities Planning Code. Therefore, it does not require a municipal land development or subdivision approval unless new structures or buildings are constructed takes effect September 8, 2015.

As per on site discussion and direction from PA DEP NERO Regional Office, an NPDES Permit should be submitted for the areas described on Pages 1 & 3 of this report. Permit package should include an E&S plan for the cut slope area as well as applicable post construction plans including BMP's, etc. for the other areas described. A. On or before September 30, 2015 a pre-application meeting between the applicant, the Dept and Conservation District is requested. B. Submit the NPDES permit application to the District on or before October 14, 2015. C. Once the permit has been issued the approved PCSM and E&S BMP's should be installed immediately.
