The regular meeting of the Roaring Brook Township Board of Supervisors was held on Thursday December 5, 2013 at 8:00 P.M. at the Municipal Building on Blue Shutters Road. Present were Supervisors Jordan, Farischon and Schield, Chief Don Hickey, Gerard Hetman from Lackawanna County, and Atty Michael O'Brien in for Solicitor Joseph O'Brien.

There was an executive session before the meeting to discuss potential litigation.

- Gerard Hetman announced activities being held throughout Lackawanna County during the month of December. He also announced there will be no tax increase for 2014.

NEW BUSINESS

- Schield said we want to replace the backhoe. A John Deere 2014 backhoe through Co-Stars that has a 3 year warranty, and an interest rate of 3.3% plus an extra \$2,000 for the old backhoe.
- A **MOTION** by Schield and seconded by Farischon to **purchase from Plasterer Equipment a 2014 John Deere Backhoe Loader with a hydraulic thumb and a Magnum hydraulic compactor. This machine will be purchased off the COSTARS contract. Total cost will be in the amount of \$59,842.60, plus the trade in of our existing backhoe. Machine will be financed through a 5 year lease purchase with john Deere credit with 1 upfront payment annually.** Motion carried.
