- Report read.
- LTAP meeting was about a Grant regarding signage upgrades for roads. Gardner Road nothing needed, Golf Club Road needs a larger STOP sign, and Summit Woods Road needs sign for curves. Roadmaster asked if some new sign could be placed on Gardner Road.
- Schield reported Water Company paving work on roads in Olwen Heights is not sufficient. Schield would like our Engineer to review work in the spring.
- A MOTION by Farischon, and seconded by Schield to have Township Engineer to inspect pave restoration of Shady and Mosswood Roads done by contractor for PA American Water. Motion carried.
- Schield would like to add Don Richardson to the list for winter plowing work.
- Jordan reported we have applied for a grant to pave Gardner Road in Roaring Brook, Moscow and Elmhurst from local share money.
- Jordan thanked Chief Hickey for applying for a COPS Fast Grant for the past several years. Grants have been given to larger cities like Philadelphia and Pittsburgh with none going to smaller communities.

### **NEW BUSINESS**

Police Department Computers – Police Department would like to get computers for their vehicles.

4 Quotes were received:

Bright \$12,953.97

L-Tron \$14,439

**CDW Government** \$15,177.94

Bedrock did not reply.

CDW Government quote met all requirements. 4G Broadband for 2 cars will cost \$39.99 each. County is providing the software and installation for the 26 municipalities and is encouraging each municipality to get computers.

- A MOTION by Farischon, and seconded by Jordan to go with CDW Government to purchase (3) computers at a cost of \$15,177.94 and (2) 4G Mobile Broadband connection at a cost of \$39.99 each per month. Motion carried.
- Backhoe Lease lease proposal for new backhoe will cost \$140.80 more per month than current payment. The current lease expires in January 2018Payment for new lease will be in arears.
- New Backhoe price will be \$112,038.00 with trade in for old backhoe of \$56,000 so new lease will be \$56,038.66 per year.
- A MOTION by Schield, and seconded by Farischon to enter into a lease for John Deere Backhoe. Motion carried.
- Jordan said there will no tax increase for the proposed 2018 Budget.

#### PUBLIC COMMENT

- Paul Kozik gave an update on oil spill at Ross Property. Kozik has looked at pipe and it is closed up. The well on property to trap any oil will remain until the spring.
- Diane Walls speeding cars is an ongoing problem on Wilcrest.
- Paul Kozik reported a compliant was received about Tom Galka.
- Mr. Galka responded to compliant and said he has permits for his home (around 1980's) and garage (around 1995).
   Permits were approved by Jim Stanton and Dan Lisecki. Septic from apartment runs through his house. He has put clean fill in back of his property and his vehicles are licensed. Jordan said that Kozik is investigating and a formal response will be received.
- Kozik said he received a call from an attorney regarding the compliant about the vehicles on the Weisel property and referred him to Attorney O'Brien. Attorney O'Brien said he told the residents' attorney that the Township does not have a specific opinion.

- Tracy Kojscza asked if she could clear her property before the conditional use is approved for building a home on her lot in a Conservation Zone. O'Brien said it is his opinion that the property should not be cleared until the approval for her conditional use request is granted. The Board of Supervisors agreed with O'Brien's advice and permission to clear the property was denied at this time. Application is filed under Tom Galka. Mr. Galka has given permission for his daughter Tracy Kojscza to act as his agent.
- Schield said Tracy's' engineer needs to address the cutting of the guiderail and the soil & erosion plan and then will be reviewed by Township engineer.
