ENGINEER' S REPORT

Voyack reported he went in March with Carmon Flynn, RBT Road Department Eric Schield and Bob Malpasse inspected manholes to check on flows during a very heavy rain. They look in Elmbrook Terrace, Crestwood and Olwen Heights. There are a couple areas in Olwen Heights where the flow was high. When the weather was dryer Schield check those manholes. He found one had pieces of broken pipe and one the seal had a leak. The decision was made to have Koberlein come in and televise the main lines. There was no success finding any breaks in the main lines. It is suspected a few homes may have a break in their laterals. Voyack will check with Koberlein to see if laterals can be televised.

Roaring Brook Estates continues to have some problems. Voyack will get a quote for new grinder pump in Roaring Brook Estates. The Authority would like SEO Paul Kozik to contact the group home to review what is not acceptable in the system.

A **MOTION** by Huester was seconded by Filipkowski to **authorize Voyack to get price and replace the check valves, if the cost does not exceed \$1,200.** Motion carried.
