 prices.

Jordan said the Township has to cover the Fire company under Worker's Compensation Insurance. Elmhurst Township does pay a portion of the Worker's Comp. Schield said Township has to provide fire protection and if there is no company within the Township they can have a agreement with a neighboring company.
- Michele Wilk asked Solicitor if she is taking over Galka lawsuit. Jenna said it is proceeding. She also asked
 about Weisel property and Jordan said he and Farischon with Paul Kozik went to visit the property and took
 pictures and plan to meet with homeowner to tell him what is allowed and a date to have it addressed.
