#### **NEW BUSINESS**

- Basket for Convention voted on earlier in Action on Correspondence.
- Veterans Memorial in Elmhurst a group of residents are trying to revitalize the area. The Township has paid for half of the annual maintenance for the area. Local businesses are going to donate supplies.
- Schield looked into purchasing a flag pole and the cost is around \$2,000. RBT Supervisors would like to help out in some way.
- A MOTION by Farischon and seconded by Schield to purchase the flag pole for \$2500 for the Veteran's Memorial in Elmhurst. Motion carried.
- North Pocono Regional Comprehensive Plan Jordan said the township is supposed to have a plan . If RBT worked on its own, it would be very expensive. Mary Liz Donato of the Lackawanna County Planning Commission will be attending the NP COG meeting and has provided funding information for the plan. Grants would be available for a \$75,000 state grant; a \$25,000 county grant; and remaining \$50,000 split between the 8 municipalities. Roaring Brook Township would have a cost of \$6,297.58.
- Figures for the NP municipalities are based on a formula method.
