## ROARING BROOK TOWNSHIP BOARD OF SUPERVISORS

The regular meeting of the Roaring Brook Township Board of Supervisors was held on Thursday, December 7, 2023, at 8:00 pm at the Municipal Building on Blue Shutters Road. Present were Supervisors Anthony Jordan, Robert Farischon and Eric Schield, Solicitor Jack Price, Chief Don Hickey, Paul Kozik, Tia and Kevin Spangenberg and Andrew Beck.

An executive session was held with Solicitor prior to the meeting to discuss current & potential legal issues.

#### PUBLIC COMMENT

- Kevin Spangenberg asked if it ok to put a domed structure for storing equipment on his land on Rte 348.
- Jordan said the Board would like to know what their future plans are for their property and was the property going to be used for storing equipment for their business. Mr. Spangenberg said they are going to build a tiny house and eventually build a permanent house. Equipment is for putting in a driveway.
- Jordan said Zoning does not allow an accessory structure without a residence.
- Schield explained the process when a new house is built and if more than one acre of land is disturbed then an E&S plan is required.
- It was asked if the equipment Spangenberg explained he reviewed what is allowed in R-3 & R-U zones and a business is not allowed in either zone. A variance would be required. Spangenberg said the equipment is for his land and not his business.
